



Statewide Impact

School districts across the state of Washington identified 39,671 K-12 students as experiencing homelessness during the 2015-16 academic year. The Homeless Students Stability and Opportunity Gap Act (HSSA) is an innovative state program that stabilizes students in both their classrooms and in their communities by providing competitive grants through the Office of Superintendent of Public Instruction and the Department of Commerce.

Educational Stability

The Office of Superintendent of Public Instruction provides \$785,000 worth of competitive grants to 39 school districts through the HSSA program. This doubled the amount of funding school districts can receive. The funds provide greater access to tutoring, supplies, early childhood education programs, and in school supports.

School-Housing Partnerships

The Department of Commerce provides \$1 million worth of competitive grants through the HSSA program. These funds expand school-housing partnerships to help identify and rapidly connect homeless students and their families with housing services in their communities. Funds can be used for rental assistance, emergency shelter, and case management. These grants are in high demand, with the Department of Commerce receiving 18 applications from across the state with a total request of \$5,170,905.
